- 3. I am satisfied that the circuit is safe for me to race upon and that should I at any time have any doubts as to its safety I am entitled to withdraw from the event thereon, and that I may inspect the circuit prior to racing thereon.
- 4. I agree to abide by the rules as laid down by Spedeworth (EA) Ltd.
- 5. I hereby give Spedeworth (EA) Ltd the right to use my name and my racing number for the purposes of advertising or publicity as they see fit.
- 6. Spedeworth (EA) Ltd will on acceptance of this agreement provide me with a Temporary Driving (Racing) Licence and number (exclusive to myself for the above race meeting).
- 7. I understand that any injury sustained by me during racing on the above named Spedeworth (EA) Ltd controlled track will only entitle me to personal accident cover as set out in the Rule Book.
