I understand that it is my responsibility to ensure that I receive a copy of the 2018 rules and regulations. I understand that I will receive only one ticket for myself for each meeting when I sign in.
- 4.1 New applicants are required to complete a multiple choice written test and a basic driving skills test before a licence will be issued. This must be arranged with the SPEDEWORTH office at the time of application.
- 5. I understand that my sponsorship, advertising rights or benefits I might receive from the same, must be with the approval of Spedeworth.
